IN MEMORIAM - Michael Blackwood

Michael A. Blackwood, 66, Marshfield, passed away on Sunday, December 1, 2019 at Marshfield Medical Center Emergency Room.

Funeral services were be held at 11:00 am on December 5, 2019 at Rembs Funeral Home, Marshfield. Burial was in Neillsville City Cemetery. Honorary pallbearers were Roger Elliott, Bill McCully, Wayne Klingelsmith and Fred Kiesel. During the funeral service Carl Budde, Roger Elliott and Wayne Klingelsmith spoke to Mike's legacy as a husband and father, colleague and friend.

Michael was born on January 23, 1953 in Marshfield, to Harry and Gertrude "Ginger" Blackwood and was a 1971 graduate of Columbus High School. He also was a 1973



graduate of Western Wisconsin Technical Institute in La Crosse where he received a degree in Biomedical Electronics. After his education, he was employed at an electronics company in Appleton. He then began his first 22 years in healthcare facilities management at St. Joseph's Hospital in Marshfield, and then at Marshfield Clinic for 17 years until his retirement. He married Judith A. Campbell Vine on June 6, 1986.

Mike enjoyed camping, hunting, boating, golfing, bowling, traveling with the "Krazy Eights" and was an avid follower of NASCAR racing, the Green Bay Packers and the Wisconsin Badgers. He was a member of the Knights of Columbus, John Eisen Council #1799 of Marshfield.

He had served on the board of directors and as past president of the Marshfield Medical Center Credit Union and the Marshfield Water and Light Commission board of directors. He achieved certification with the American Hospital Association in healthcare facility management. Mike was a talented handyman who always had time to help out others whenever asked. members at the best prices available. The programs are offered to you in your buildings or within a close proximity of your facilities. Over 5,500 people have attended an education program over the 2019 calendar year.





December Business Meeting:



Where Are They NOW? by Roger Elliott

The Where are they Now? feature appeared in WHEA newsletters with some regularity in the late '90's and early 2000's, and was originally conceived as a way to let active members know what some of our more recognizable retirees were up to. It has not been included since the last article about the passing of our last founding father, Bob Botts. To a certain extent, that is due to the creation of our Resource Committee where many of our more active members have been participating since they've retired and we pretty much know what they've been up to!

I'm happy to say, however, that perhaps our most notable retiree, Carl Budde was kind

enough to provide us recently with what he titled his "Bio," but of course, it's really his autobiography relative to his life experiences influenced by his years of working and volunteering within the healthcare industry. His story is truly amazing and should serve as an inspiration to all of us who've had the privilege of working in healthcare engineering. Over my 35+ years in WHEA I've often spent time with Carl in conversation about our work, our love for WHEA, our personal lives and our faith, but for those of you who've not had that opportunity we're glad to be able to offer Carl's story to you in this issue of the newsletter...


Having reached age 80, I look back on my life and have become more aware how God has provided many opportunities and blessings. Let's begin.

As an 8 year old, the youngest of 5 children and raised in Beaver Dam in a strong Catholic home I became an altar boy and serve mass at St. Joseph's Hospital. While you may wonder why I would include this you will see how that connection with the hospital had two significant blessings in my life. I served mass there for 11 years.

One of the benefits of serving mass at St. Joes was that it also included breakfast. In my later teen years St. Joseph's was a host for a student nurse's intern program with the Sacred Heart School of Nursing from Milwaukee. The nurses had breakfast at the same time that I did.

One of the students was Joyce Pruden. We had our first date on July 1, 1959 and 15 months later we got married. At that time I was a carpenter working for a contractor who did mostly residential buildings.

By 1963 we already had two children and I needed to find a job that provided steadier pay. St. Joseph's hospital was looking to fill a maintenance position. I *(continued on page 13)*

applied and got the job. My first day on the job was July 22,1963. Being the new guy on the job I worked the "swing shift". When the second and third shift guys had the day off, I was assigned their shifts.

The "chief engineer" at that time was Joe Hahn. He was part of a group of hospital engineers that met monthly. He would invite any of his maintenance staff to join him. My first meeting was in September, 1963 at Madison General Hospital and the host was a guy by the name of Bob Botts. In 1965, that Madison group became Chapter II within the state organization, Wisconsin Hospital Engineering Association (WHEA). I served as Chapter II president in 1968.

In 1969, I was fortunate to attend a 5-week hospital engineer course at University of Minnesota. The timing was such that I was allowed to take 5 weeks of accrued vacation -- in that era you were allowed to carry over vacation hours from the previous year (another of God's blessings).

I didn't realize it at that time, but a national engineering group, the American Society for Hospital Engineering (ASHE) co-sponsored that program. Each of the 5 weeks we had what they called a "coach" from ASHE to mentor the students. That is when I met a guy by the name of Bob Paul, from Texas. I still connect with Bob who is well into his 90's.

That same summer the nuns from the Order of Saint Francis at Saint Josephs Hospital had a consultant visit our hospital. His name was Robert Putnam. I was able to have a conversation with him about the role of "chief engineers" and the level of education and experience it would take to achieve that position. He said there were many opportunities out there, but that I should be prepared to move from Beaver Dam if I wanted to advance in the hospital engineering field.

In the fall of 1969 I interviewed at Mount Sinai Hospital in Milwaukee and at Waukesha Memorial Hospital (WMH). I was hired as a maintenance foreman at WMH. My first day of the job was November 3,1969. Within a short period of time I enrolled at Milwaukee School of Engineering (MSOE) where I received my 1st class operating engineer's license. I also connected with WHEA Chapter I. I soon learned that unlike Chapter II, you had to be at the "supervisory level" and an employee of a "hospital" in order to be a member. kicked out when I asked if I could bring some of my maintenance staff to the meetings. I served as Chapter I president in the late 70"s

My career at WMH quickly advanced as I was promoted assistant to the chief engineer in the early 70's and became the chief engineer in 1975. By the mid 80's that position changed to VP of Facility Services. I became responsible for managing architects, engineers and construction on all projects as well as facility services, which included maintenance, plant operations, medical electronics, housekeeping, dietary, safety and security.

I continued to be active in WHEA serving on several committees. While there were many active members serving on committees, I want to pay special tribute to Joe Plonka. Joe and I worked together to develop the first WHEA directory in 1987. Joe worked behind the scenes for many years. He not only gave a lot of his time on behalf of the WHEA members but was a fun guy to be with. In addition to being active on several committees, I served as state president in 1984. It was in that era that we introduced membership level of Associate Members to WHEA. Initially, Associate Members were limited to sponsoring coffee breaks. While they obviously were not allowed the privileges of Full Members, that opened the door to what became a partnership between WHEA members and vendor/ contractors. Of course the rest of that is history.

I attended my first ASHE annual conference in 1975 at which time I also became a member of ASHE. I continued to attend the annual conferences each year and in the late 80's was elected to the ASHE board as a Region 5 representative. At that time Region 5 also included Michigan, Ohio, Indiana and Illinois. I served on the board from 1990-94. I was nominated and elected as ASHE president in 1994, serving as president elect in 1995 and president in 1996. Both the administrative team at Waukesha Memorial Hospital and WHEA continued to provide much needed support during those years.

My President-elect and Presidential years were filled with a lot of travel nationwide along with attending board meetings. Working with an ASHE team that included Doug Erickson, ASHE provided a leadership role in creating a partnership with The Joint Commission on Healthcare Accreditation (JCAHO). I look back at that as one of ASHE's larger successes thanks to the leadership of both ASHE and Joint Commission. Doug Erickson and Dr. Al Buck from JCAHO played a major role in developing that partnership.

WHEA was considered one of the leading affiliated chapters of ASHE because of the continuing education programs provided for its members. Having traveled Region 5 for 4 years and many chapters country-wide over my two years as President-elect and President, it became obvious that WHEA was one the top ASHE chapters if not the top chapter.

As I reflect back, starting as an altar boy in a hospital, God connected me with the love of my life, Joyce and after a short career as a carpenter, opened the gates to a 37-year career in healthcare. Equally important was being an active member of WHEA and ASHE, which helped me keep current with the many challenges we faced in the healthcare engineering profession--specifically code issues. Receiving my 50-year plaque from WHEA is what I call the frosting on the cake.

In retirement Joyce and I continued in our nursing home ministry; performing gospel and country music in several of the nursing homes in the Waukesha area. Being retired for nearly 20 years it continues to be those personal relationships with our WHEA and ASHE friends that we hold special. Having just celebrated our 59th wedding anniversary, Joyce and I are thankful for the many blessings God has provided us; including 4 children, 13 grand-children and 13 great-grand-children.

Energy to Care Award!

The Energy to Care Awards honor health care facilities that reduce energy consumption by 10 percent in a single year or by 15 percent over two years. The program also recognizes previous year award winners that reduce energy consumption by 5 percent. Applications are due April 1, 2020.

Energy Champion Award

The Energy Champion Award is given out once per year to honor a single facility (acute care hospital or medical office building as defined by Energy Star) that has demonstrated outstanding leadership in energy efficiency. Hospitals and medical office buildings participating in Energy to Care that have an ASHE member on staff are eligible for this prestigious award. Applications are due April 1, 2020.



ASHE Advocacy Liaison Update

On December 11, the advocacy liaisons met in conjunction with the Sustainability liaisons.

The most pressing issue at this time is preparing for the NFPA conference. ASHE is seeking members to attend the June 15-18 2020 Technical meeting in Orange County CC in Orlando Florida. We are hoping for approximately 300 members to be present and voting for this meeting. This is a call for all ASHE members who belong to the NFPA to prepare and plan for participation in this important advocacy effort.

A presentation was provided by Kara Brooks (ASHE Sustainability Program Manager) on the

Energy to Care Dashboard. Members are encouraged to participate in the program to allow healthcare to better tell their story about our energy conservation efforts. There are training videos available on the site at:

The data that has been entered into the dashboard at this time is being scrubbed as there were some data integrity issues identified. We look for our sustainability colleagues to provide further updates as this program develops.

An update was presented regarding the FGI and potential changes to this document. ASHE has identified a few major concerns proposed including removal of the ASHRAE 170 from the document, additional Eye Wash and Emergency Shower requirements, Specialty areas in the Emergency Departments, Inclusion of Inpatient Services within Outpatient Chapters, and an expansion of Behavioral Health requirements throughout facilities. The proposals are under review at this time by the Healthcare Guidelines Revision Committee. The review consists of document groups conference calls with an all hands meeting scheduled for March 2020.

ASHE announced the Energy to Care Awards for next year. All applications are due April 1, 2020. All facilities are encouraged to apply for Energy to Care Award, the Energy to Care Champion Award and the Energy to Care Chapter Challenge.

The ASHREA 170 has one addendum (Addendum L) open for public comment to December 22. The purpose of the addendum is to continue the process to reorganize the document into the three documents (Hospital, Outpatient, Residential). The addendum also incorporates all of addendum A and Q into all sections.

For the year of 2020 the Advocacy and Sustainability liaisons will have joint calls on February 26, May 20, and December 9. There will be a face to face meeting planned for Chicago on October 29-31 with all the liaisons as future planning efforts continue.
