Advocacy:

FGI – Facilities Guidelines Institute

The committee continues to advocate on behalf of its members. We participated in submitting code change proposals for the proposed Standards. This year three members were present at


the April HGRC Facilities Guideline 2010 Standards held in St. Louis for the final review session. Roger Lautz, Jon Cechvala, and Wade Rudolph fully participated in the modifications. Soens, a voting member provided input, but could not attend in St. Louis. The FGI committee now includes members from ASHRAE. Jeff Boldt and Roger Lautz were very instrumental in mechanical code change proposals. The new Standard is to be available in 2010. Voting ballots were sent to all 130 national participants on September 28, 2009.

NFPA 99

The committee is advocating by providing input through Roger Lautz, Tom Spremo, Bill Best and Jeff Boldt to the new proposed NFPA 99 Code Standard.

State of Wisconsin

The committee is also advocating at the state level by participating on the electrical advisory committee through Gordy Pierret and Tim O'Rorke, the plumbing advisory with committee Boldt, Jon Cechvala and Wade Rudolph, the elevator code advisory committee with Grea Graunke and the boiler and pressure vessel advisory committee with Joe Bena.


At our last meeting on October 16, we discussed:

North Dakota now has


an ASHE affiliated chapter. We now have all five Region 6 states with an ASHE chapter.

Get "Usernames" and "Passwords" for Access to WHEA Members Only Website By Roger Elliott



All WHEA members are eligible for access to the WHEA website "Members Only" pages. This is the area where the privileged information provided exclusively to our members is posted and maintained. Access to this area is restricted via use of unique user names and passwords that are set up for each member. If you are a WHEA member and have never requested a password from us, you'll need to contact our Administrative Assistant. Jane Bruvold at bruvold@sbcglobal.net and she'll be happy to get you started. Here's the general process that we follow for all members requesting access to the Members Only pages of www.whea.com......

User names are always the members' first initial of their first name and their last name, all in lower case -- no exceptions (example: Smokey T. Bear becomes sbear.).

Once the new member has submitted his/her choice of password to Jane, she will build it into the website security file, test it, and let the new member know that it's set up. Thereafter, if the password is not changed but is forgotten, the member can click onto the "Forgot Password" link on the login page and the system will automatically mail the password to the members' email address - just another reason why you need to keep all your demographic information current with your chapter Member Services representative. If you don't, you miss a lot of important WHEA communications and will lose access to the Members Only site!
